TIMELINE

What we now know as the United Way of the Ocoee Region, began as the Community Chest in 1938.
During this first year, around \$3000 was allocated to two agency partners.

Local donors rallied to support the effort in WWII and the campaign goal tripled when the War Fund in Tennessee was added as a partner agency.

The United Fund of Bradley County becomes the United Way of Bradley County and raises over \$450,000 to be distributed among 18 different agency partners.

United Way moves to current location in the old Princess Theater and the campaign reaches \$1,000,000 for the first time.

The United Way campaign reaches \$2,000,000 for the first time.

The United Way of Bradley County recieved \$19.7 million from the sale of Bradley Memorial Hospital which became the Bradley Memorial Heath Endowment Fund.

The first grants are awarded through the Bradley Memorial Health Endowment Fund. A total of \$399,172 is distributed to 9 nonprofit different organizations.

The United Way of Bradley County conducts our first large scale needs assessment, identifying adult dental care as a top un-met community need.

The VISTA (Volunteers in Service to America) program brings over 15,000 hours of volunteer time to organizations in our community.

The United Way of Bradley County becomes the United Way of the Ocoee Region to better represent our service area of Bradley, Polk, and part of Fannin County, GA. The United Way's Center for Social Impact is formed to work closely with local nonprofit organizations to help them grow and develop to best serve our community.

The United Way of the Ocoee Region invests over \$3,000,000 through the Campaign and the Health Endowment Fund in over 40 nonprofit partners that are working to meet our community's greatest needs.
